# 1. Qualification Information

## Purpose Statement

This qualification is designed to give learners the knowledge, skills and competencies to provide clinical supervision for counselling practitioners. It is aimed at counsellors who have acquired sufficient client work experience to contemplate the move into a clinical supervision role.

Participants will need to:

- Have both supervisees and supervisory supervision.
- Be working as counsellors under supervision.

This qualification is designed to lead to a role as a clinical counselling supervisor in a counselling agency or in independent practice. Supervision is an ongoing professional requirement for all practising counsellors and those with a recognised qualification are more likely to find employment.

Successful candidates will be able to work as counselling supervisors in a range of job and career opportunities, which include but are not limited to:

- A supervisor employed by an agency or organisation that offers individual counselling to adults
- A private supervisor working for an organisation such as a wellness/ mental health setting
- A supervisor in private practice
- With further training, a supervisor in an agency or organisation that offers counselling to couples or to children and young people

### 3. Minimum Assessment Requirements

To achieve the qualification, candidates must be internally assessed as **Proficient** in all 7 learning outcomes of the qualification.

Candidates must give **two** pieces of evidence for each criterion. In addition, the Candidate Learning Record (CLR), when complete, must include references to all three assessment methods (documents, tutor observation and testimony).

## 5. Candidate Entry Requirements

This qualification is not suitable for those who are currently in a state of severe emotional difficulty and/or severe psychological distress. Centres need to ensure that all potential candidates are made aware of the nature of the course, and in particular that the course involves experiential elements that will involve some personal disclosure and associated personal developmental activities.

## 6. Fit for Purpose

This qualification leads to being a qualified supervisor for counselling practitioners and fulfils the requirements of a range of professional association registers. It also maps to a range of competency frameworks. This section is intended to help learners make informed choices about the qualifications they wish to study and how they will enable them to reach their personal and professional goals.

As a learner continues their journey with the **CPCAB Level 6 Certificate in Therapeutic Counselling Supervision**, they are progressing into post-practitioner training which enables them to develop further skills, knowledge when providing clinical supervision. This improves employment opportunities to work as a supervisor in services which offer counselling and also in independent practice.

CPCAB qualifications are designed to build upon each other, ensuring that the required skills and knowledge are developed alongside the personal growth of the learner. This qualification is based on current research and adheres to the [CPCAB's model](#) for practitioner development, ensuring that training meets the highest professional standards.

Learners will receive live teaching either in-person or in an online classroom, which will include real-time interaction with peers and tutor(s). They will practice what they are learning, receive feedback on their use of supervisory skills, and gain insights about themselves through their engagement with others. This live human connection is considered essential when training in an area such as counselling and supervision.

### Counselling and Psychotherapy Career Progression

The TCSU-L6, in addition to core training, enables learners to register as a supervisor with the following counselling professional association registers, which are accredited by the Professional Standards Authority (PSA):

This alignment ensures that this qualification is not only comprehensive but also up-to-date with the latest practices in counselling, psychotherapy and other linked professions.

The assessment strategy maintains a focus on practitioner skills and qualities as well as on written evidence. The combination of tutor assessment and separate external verification by CPCAB values both objective independent scrutiny and the relational knowledge of the candidate and their work. The qualification is reviewed annually to ensure it remains fit-for-purpose.

Centres have to meet robust centre approval requirements before they can deliver this qualification. All tutors are approved and standardised by CPCAB and centres are visited twice a year by a CPCAB external verifier.

## 7. Progression Routes

There is currently no further progression route beyond TCSU-L6 within CPCAB qualifications.
